4. Fire Officer can check the arrangements of fire safety at any time, this certificate will be withdrawn without any notice if any deficiency is found.  
The fire brigade officer can check all these arrangements at any time, if any deficiency is found then this certificate will be considered canceled without any notice.
5. Occupants/owners should apply for renewal of fire safety certificate one month prior to expiry of this certificate.

The owner shall be bound to renew the fire safety certificate issued one month before the expiry date.
